From: President Jeri Thornsberry

Last week, I had the honor of representing Iowa at the National Association of Conservation Districts, where I served as Iowa's delegate. The meeting was held in Salt Lake City, with a mild 40-degree temperature, setting the stage for a meaningful gathering. This year's theme was "Bee the Change," inspired by Utah's state symbol, the Beehive, which represents working together mirroring the state's motto of Industry.

Throughout the event, NACD highlighted the importance of partnership and collaboration in conservation efforts. With increasingly severe weather events impacting our country, it is more vital than ever that we work together to implement conservation practices and protect our land.

However, the funding freeze enacted by the administration has had serious consequences. As a result, CDI furloughed 38 of 39 employees. On February 14, I received an unexpected email notifying me that a grant in Black Hawk County had been canceled. Strangely, no one in the NRCS chain of command had been informed. These funding cuts and terminations of federal employees, along with the cancellation of agreements, are deeply impacting our districts.

It's becoming more difficult to provide vital services to both our rural and urban communities.

Despite these challenges, I remain hopeful. I believe we've just hit a large pothole in the road, but our tires are still intact, and we will keep going. 2025 is a year of celebrations: NRCS will mark its 90th anniversary this April, IDALS is celebrating 56 years, and many districts will celebrate their 80th anniversary this year.

The work of conservation is never-ending. We get knocked down, but we always rise again. We will continue standing strong, no matter the obstacles.

Our Spring Regionals begin next week, and now is the perfect time to get involved. Your voice has never been more important. Join us and make a difference!

Executive Director Report – Dien Judge

On Tuesday, February 11, Conservation Districts of Iowa made the difficult decision to lay off 38 employees. Under three grant agreements through the USDA-NRCS, Conservation Districts of Iowa is supposed to be reimbursed for the payroll costs of these employees.

CDI is currently waiting for tens of thousands of dollars in reimbursements from these grant agreements, and we have received no clear guidance from NRCS about when these reimbursements will be paid. Our hope is that this issue will be resolved soon, our grant invoices will be paid, and we can bring our people back to work.

The positions on layoff include: 24 Administrative Support Specialists; 5 Land & Water Conservationists; 3 Conservation Wetland Specialists; 3 Wetland Engineering Technicians; 2 Conservation Planning Coordinators; 1 Program Manager.

These folks have been stationed all around the state of Iowa, working hand-in-hand with farmers, landowners and our partners at the local, state and federal level to make soil & water conservation projects happen for the good of our state.

Please contact your Senators and Representatives and let them know that these employees do good work for Iowa, and we want them to get back on the job.

The following week will kick off with the Region 1 meeting hosted by Cherokee SWCD in Cleghorn. On Wednesday, March 5, Hamilton SWCD will host the Region 2 meeting in Webster City at 10:00 AM, followed by Hardin SWCD hosting the Region 3 meeting at 4:00 PM in Hampton.

We wrap up the Spring Regionals with the final meeting in Region 4, hosted by Allamakee SWCD at 10:00 AM in Waukon. We look forward to visiting with you at your regional meeting.

Iowa recognized for commitment to conservation at NACD meeting

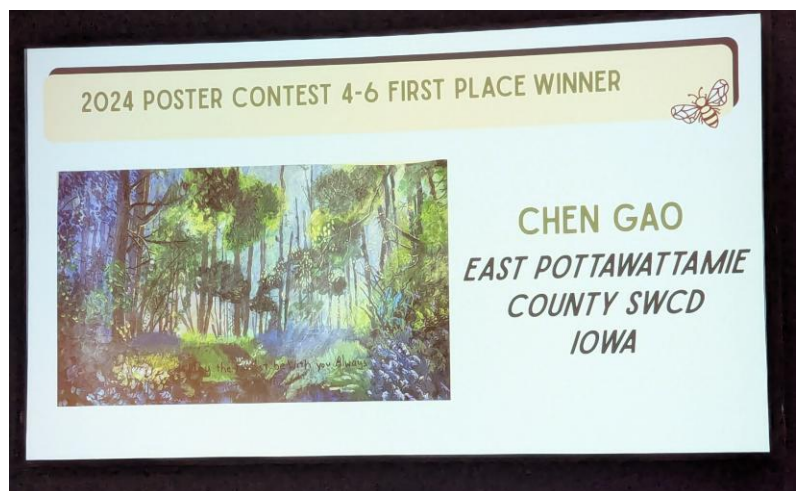

The National Association of Conservation Districts held its 79th Annual Meeting Feb. 8-12 in Salt Lake City, Utah, bringing together conservation leaders from all around the United States. Conservation Districts of Iowa was represented at the meeting by CDI President Jeri Thornsberry and Vice President Eric Wessels, who attended various program events throughout the meeting. CDI Executive Director Dien Judge also attended, and he participated in a meeting of the Association of Conservation Executive Directors.

During the meeting, Iowa was recognized as one of the top ten contributing states to NACD. Iowa ranks seventh in total dollars contributed to NACD. Thornsberry accepted a recognition award from NACD President Kim LaFleur.

NACD also announced winners of the 2024 Poster Contest, and Iowa had a winning entry. The poster made by Chen Gao of East Pottawattamie Soil and Water Conservation District was the first place winner in the Grades 4-6 category. Congratulations to Chen Gao on this national award!

The National Conservation Foundation (NCF) Envirothon is an environmental and natural resource conservation problem-solving, team-building, and leadership experience and competition for 9th – 12th grade students across the U.S.

Iowa Envirothon challenges students statewide to hone critical thinking skills and create inventive solutions to the complex local environmental and natural resource issues facing Iowans today.

Through regional testing and the state competition, teams of Iowa high school students earn a chance to deep dive into valuable environmental and natural resource problem-solving, team-building, and leadership experiences. In Iowa, the Conservation Districts of Iowa (CDI) manage this competition. Starting in 2024, the [Iowa Conservation Education Coalition](#) (ICEC) is partnering with CDI to promote this program!

In Iowa, teams of students sign up for a regional, on-line exams. The teams with the top 15 scores at the regional level are invited to the state competition at a central Iowa location in the spring.



Resolutions due Friday, March 28

The 2025 Call for Resolutions has been sent out to all Conservation Districts of Iowa offices. This process provides every member of Conservation Districts of Iowa the opportunity to make your voice heard by bringing issues and concerns to the attention of state and federal decision-makers.

Throughout the 2025 Resolutions Process, all resolutions will be properly reviewed by the broader conservation community before being submitted for action.

This year, the deadline for submitting resolutions is Friday, March 28, 2025. Resolutions submitted after this deadline will not be considered for the 2025 cycle. In prior years, some resolutions submitted could have been handled with conversations and/or negotiations with one of our partner agencies. CDI encourages districts to work with the appropriate agency first. If the district is not satisfied with the outcome of those discussions or negotiations, then submit the resolution for consideration.

If multiple districts submit similar resolutions, CDI may combine them into one unified resolution. This strategy will strengthen the position of the districts and provide a clearer, more cohesive argument when presenting the resolution. We once again offer pre-conference resolution voting by mail for commissioners. The goal is to have all 500 commissioners from Iowa's 100 districts to participate in the voting process. Last year, there were close to 400 pre-conference pre-conference ballots cast – this year, CDI hopes to surpass that number.

CDI Scholarship applications to be sent to Regional level

Conservation Districts of Iowa scholarship applicants have submitted their applications to local SWCDs, and now each local SWCD is forwarding their top application to their regional director by March 14.

In April, 2025, a judging team of CDI officers, regional directors and alternates will make the final decisions. Scholarship applications are judged based on the following criteria: 20 points for Involvement, Leadership and Character; 20 points for Career; 30 points for Scholastic Achievement; 30 points for Conservation Message.

CDI will make the announcements about the winning applicants on Friday, May 2. After the final selections, the top three scholarships will be awarded at the state level in the amounts of \$3,000, \$2,000 and \$1,000. Winners from the remaining six regions will each receive \$500.

First, second and third place awards will be paid directly to the applicant's school of choice in two equal installments, one upon enrollment at the beginning of the year and the second at midterm. The six other scholarships will be paid directly to the applicant's school of choice in one installment.



CDI Poster Contest announced

Rules for the CDI 2025 Poster Contest have been released, and are available at this [link](#). The annual NACD and NACD Auxiliary Poster Contest provides students from kindergarten through 12th grade the chance to have their art displayed as part of a national conservation outreach initiative. Each year, the winning posters highlight the work of conservation districts and their state conservation associations, auxiliaries and agencies to protect and enhance natural resources. The contest starts at the district level; winners advance to the state level, and then to the national level, where they receive recognition at NACD's annual meeting. The poster contest is open to public, private and home-schooled students. The top three posters in each category of the national contest will receive monetary prizes. First-place winners will receive \$200; second place winners will receive \$150 and third place winners will receive \$100. For all those who entered, local sponsors may offer each a special Participation Certificate to recognize their participation. The NACD Auxiliary – through their quilt project proceeds, the Country Store at the NACD Annual Meeting and individual donors – sponsor prizes at the national level.

Incentives available for landowners in Climate-Smart Commodities Horizon II program

Through an \$80 million USDA Partnerships for Climate Smart Commodities grant awarded to a partnership of 13 public and private entities led by Roeslein Alternative Energy, Horizon II will provide owners of highly erodible land significant income to participate in the project.
