# As Iowa Legislative Session concludes, state conservation funding steady

REAP Program extended into 2028

The Iowa Legislature was adjourned on May 15 in the early hours of the morning, after passing a budget of \$9.452 billion for fiscal year 2026.

The budget had been delayed following a push to limit the use of eminent domain for carbon capture pipelines.

Funding for conservation programs remains steady, with strong support from the Agriculture and Natural Resources Appropriations bill, and the Infrastructure Appropriations bill, which were both approved by the Iowa House and Senate.

Appropriations of interest in these bills

include: \$1 million for the CREP Program; \$900,000 for Watershed Protection; \$900,000 for the Conservation Reserve Program; \$8.2 million for Soil and Water Conservation (from Enviro First); \$3.8 million for Soil and Water Conservation Administration; \$2.375 for the Water Quality Initiative (from Enviro First); \$12 million for REAP; \$525,000 for Forest Health Management; \$150,000 for Iowa State University Extension private lands forester; \$200,000 for IGS Groundwater Assessment; \$8.2 million for the Water Quality Initiative (from RIIF); \$9.6 million for the Lake Restoration program.

The REAP (Resource Enhancement and Protection) program has been extended for three years, as a result of the passage of this legislation as well, which will ensure funding for REAP until June 30, 2028.

Conservation Districts of Iowa represents you, and supports your priorities, at the Iowa Capitol. During the annual legislative session, CDI employs the services of Jim Obradovich and his team at the Capitol Group firm to promote our official Conservation Districts of Iowa Resolutions and monitor any legislation that would be detrimental to our mission in soil and water conservation.

# CDI staff are back on the job after federal funding 'pause'

Many CDI staff members have returned to their positions following the unfortunate layoffs that were caused in February by the Trump Administration's "pause" in federal payments for grant programs. The pause in payments has ended, and all staff members were offered the opportunity to work for CDI once again.

Grant funded program staff began returning to work over the course of the last three months. This

includes CDI program staff in the Conservation Planning Program, the Private Lands Conservation Partnership Program, and the CDI Administrative Support Program.

CDI Executive Director Dien Judge said the first goal was to bring back any staff members who wanted to return to work for CDI, and then to fill any open positions as soon as possible.

"Our dedicated, experienced staff members are vitally important to this organization, and they work

Coordinator position, joining Madison Conley in the program to assist districts in updating and maintaining five-year conservation plans. Carlee and Madison bring a wealth of experience to the table, and will be contacting districts about the conservation planning process in the months to come.

# Poster Contest entries evaluated

entries for the contest were due April to their local Soil & Water Conservation Districts, and are being evaluated at the local level.

Before June 27, 2025, local SWCDs will choose one district winner from each of the five grade categories and electronically submit the entries to their CDI Regional Director via email with a photo of each winning poster and their poster contest entry form. The top three posters in each category of the national contest will receive monetary prizes. First-place winners will receive \$200; second place winners will receive \$150 and third place winners will receive \$100. For all those who entered, local sponsors may offer each a special Participation Certificate to recognize their participation. The NACD Auxiliary – through their quilt project proceeds, the Country Store at the NACD Annual Meeting and individual donors – sponsor prizes at the national level.

# CDI Scholarship spotlight: First Place Scholarship Winner Halaina Crane



Halaina Crane, of Mt. Pleasant, is the winner of the 2025 First Place Scholarship from Conservation Districts of Iowa. She is planning to attend the University of Wisconsin, Stevens Point.

Halaina Crane, from CDI Region 9, is the winner of CDI's First Place Scholarship award, and will receive \$3,000 toward her college education. Halaina is planning to attend the University of Wisconsin Stevens Point.

"My name is Halaina Crane, and I have lived in Mt. Pleasant my whole life. I spend much of my time playing guitar, listening to music, gardening, caring for my three dogs and cat, and simply spending time outdoors," she said.

"Since I was young, I have always felt a deep passion for nature, whether that be listening to bird calls with my grandfather, catching fish, frogs, and bugs, or looking for morels whenever the season would hit.

"Growing up, I was always fascinated by the nature programs they would show on television, but I came to realize that they only ever talked about places far from home; What was going on in the Midwest? This question prompted me to begin deep research into North American ecosystems, and with the help of those around me and the experiences I gained, I have come to realize that it is my calling to conserve our native

lands. I am beyond grateful for this scholarship and will be attending the University of Wisconsin Stevens Point to major in Forestry with an emphasis on Ecosystem Restoration and Management so that I gain the skills and knowledge to help protect our natural world."

The Second Place award of \$2,000 will go to Sage McLaren of Fremont County. The Third Place award resulted in a tie, so two third place awards of \$1,000 will be given to Garret McBeth of Boone County and Parker Messerich of Clinton County.

Awards of \$500 will be given to Colton Warren of Woodbury County, Elliott Carlson of Humboldt County, Danielle Wagner of Grundy County, Maranda Wood of Jackson County and Lola Comes of Cass County. Scholarship awards are sent directly to the college or university in August.
