

Bird Conservancy of the Rockies seeks info from farmers and ranchers

Bird Conservancy of the Rockies (BCR), a 501(c)(3) nonprofit based out of Fort Collins, CO, is asking for your help in understanding levels of support for, and barriers to, voluntary conservation among farmers and ranchers in the U.S. Great Plains. BCR is planning to send a survey to approximately 950 conservation district managers (or other staff or board members, whoever feels the most qualified to respond) to help estimate the level of support for several voluntary conservation behaviors within their districts. They will also ask about barriers and resource constraints relevant to voluntary conservation within these areas. Ultimately, the research team will combine these data with ecological maps of key areas for bird conservation across the Great Plains to understand, for each responding conservation district, (1) what are the levels of social support for voluntary conservation within a given conservation district, (2) what are the primary resources constraints and barriers to voluntary conservation in a given district, and (3) what are key districts to focus on for bird conservation, and how can we allocate resources and outreach to make these efforts more impactful? The survey will launch in mid-to-late September, so keep an eye out for it in your email inboxes and please consider supporting this research. Conservation Districts of Iowa Annual Conference Report A Year in Review 2024–2025

The Conservation Districts of Iowa (CDI) exists to support Iowa's Soil and Water Conservation Districts and their commissioners by advancing conservation through public education, advocacy, commissioner development, policy engagement, on-the-ground project support, and more. The following is a comprehensive review of CDI's efforts over the past year, made possible by the ongoing support of dues-paying commissioners, grant funding and district partnerships.

How CDI Supports Commissioners Year-Round

CDI's core mission is achieved through an ongoing commitment to service, communication, planning, and advocacy, including:

Leadership and Office Staffing

CDI employs a full-time Executive Director, Dien Judge, and Program Assistant, Regan Davis, as office staff. Contract lobbyist Jim Obradovich, The Capitol Group, is invaluable to CDI to carry out its daily operations and strategic initiatives.

Field Staffing Supporting Districts-Funded Through Grants

Conservation Planning Assistance

CDI offers services to help districts revise as needed their completed five-year Soil and Water Resource Conservation Plans in compliance with Iowa Code Chapter 161A. Planning Coordinators Madison Conley and Carlee Sabus have split the districts to accomplish their deliverables in the 5-year grant program.

Administrative Support and Private Lands Workforce

CDI entered into agreements with the NRCS and Iowa DNR to provide:

- 25 Administrative Support Staff across NRCS Resource Teams
- 5 Conservation Wetland Specialists
- 5 Land & Water Conservationists
- 5 Wetland Engineering Technicians

Information Sharing and Communication

CDI keeps commissioners and staff informed through its *Connections* newsletter, regular email updates, the CDI website, and by organizing the Spring Regional Commissioner Meetings and the Annual Commissioner Conference and Business Meeting—two meetings a year where commissioners gather with peers to network and learn.

Support Services for Commissioners and Districts

CDI assists with operations, guidance on financial and legal responsibilities, district staffing announcements, updates on conservation practices, and sharing local issues and opportunities. CDI also attends commissioner meetings, responds to direct district requests, and maintains resources at www.cdiowa.org.

Policy, Advocacy, and Representation

CDI represents commissioners at local, state, and national levels. Activities included:

- o Managing the Resolutions Process to shape conservation policy both nationally and statewide.
- Organizing the annual Conservation Partnership Day at the Iowa Capitol.
- Participating in NACD events, national committees, and U.S. legislative meetings.
- o Filing required reports to the U.S. EPA through lowa's DNR's Nonprofit Source Program.

Education, Scholarships and Youth Engagement

- Hosted the 28th Annual Iowa Envirothon, reaching 315 students in 63 regional teams and 65 students in 13 state-level teams.
- The Decorah "Load of Carp" team represented Iowa at the 2025 NCF-Envirothon in Calgary, Alberta Canada.
- Conducted the CDI Poster Contest. Winning posters are featured at this conference and submitted to the national competition. For the 2024 competition, lowa's first national poster award was given to Chen Gao (Category 4th – 6th grade) from East Pottawattamie SWCD.
- Awarded \$9,000 in scholarships to students pursuing conservation and agriculture-related degrees made possible by generous district donations and proceeds from the Silent Auction at annual conference
